

Indicates they are engaged in a "normal conversation" and they are laughing, aithough he does not know the content of the conversation. asked have how he wants to pay for the pizza and have states cash. then goes downstairs.

stated they Detective Tacey asked him to be specific about what they were talking about. were up there "messing around." Detective Tacey had him define "messing around."

Detective Tacey asked what the timeframe was that this occurred.

they entered the residence to the time that he went upstairs was approximately five to 10 minutes.

He believes they arrived at the residence at approximately 0200 hours.

stated that after he came down, he believes that both of the girls went upstairs to check on Detective Lencioni asked if he knew that for certain. He indicated it was just an assumption. He stated that the other two girls stayed at the residence for approximately 30 minutes and then left there. stated that after the girls left, a short time later that came down and stated that everything was alright.

They sat in the living room and were having conversations with the other males, whom he identified as and indicated that he was not really paying attention to these conversations since he does not know the subjects involved, and that he was on the computer. Indicated that he did hear as a saying something in regards to her and doing something of a sexual nature.
It was around this timeframe that the pizza arrived. Upon questioning, the stimated it to be around 0300 hours.
then continues talking to stating she is a grouple for rappers, indicating a person who hangs around a specific group of people in order to obtain sexual or other favors from them.  The state of the s

Detective Tacey questioned him about the incident with the person going upstairs with the 1800 tequila bottle to give a drink to the land he stated he does not recall that happening, and he was not the person who went upstairs.
Detective asked how much that no one was drinking at the residence when they returned back from the club.
