October 26, 2011, Introduced by Senators HOPGOOD, JONES, BIEDA, BRANDENBURG, ANDERSON, JOHNSON, NOFS, GREGORY and YOUNG and referred to the Committee on Judiciary.

A bill to amend 1931 PA 328, entitled "The Michigan penal code,"

(MCL 750.1 to 750.568) by adding section 225.

THE PEOPLE OF THE STATE OF MICHIGAN ENACT:

- 1 SEC. 225. (1) EXCEPT AS PROVIDED IN SUBSECTION (2), A PERSON 2 SHALL NOT DO EITHER OF THE FOLLOWING:
- 3 (A) REMOVE, DISGUISE, CLOAK, COVER, CONCEAL, OR MASK THE 4 COLORED MARKINGS REQUIRED ON A TOY, LOOK-ALIKE, OR IMITATION

FIREARM UNDER THE LAWS OF THIS STATE OR OF THE UNITED STATES.

- 6 (B) ADD OR INSTALL ANY COLOR OR MARKINGS THAT ARE REQUIRED FOR
 7 AN IMITATION FIREARM UNDER THE LAWS OF THIS STATE OR OF THE UNITED
 8 STATES IN A WAY THAT MAKES A FIREARM LOOK MORE LIKE AN IMITATION
 9 FIREARM.
- 10 (2) A PERSON WHO VIOLATES SUBSECTION (1) IS GUILTY OF A FELONY
 11 PUNISHABLE BY IMPRISONMENT FOR NOT MORE THAN 18 MONTHS OR A FINE OF

- 8 MANUFACTURED EXCLUSIVELY TO PROPEL BBS THAT DO NOT EXCEED .177
- 9 CALIBER BY A SPRING OR BY GAS OR AIR.
- 10 (B) "FIREARM" MEANS THAT TERM AS DEFINED IN SECTION 222.
- 11 (C) "IMITATION FIREARM" MEANS A BB GUN, TOY GUN, REPLICA OF A
- 12 FIREARM, OR OTHER DEVICE THAT IS SO SUBSTANTIALLY SIMILAR IN
- 13 COLORATION AND OVERALL APPEARANCE TO AN EXISTING FIREARM AS TO LEAD
- 14 A REASONABLE PERSON TO PERCEIVE THAT THE DEVICE IS A FIREARM.
