Detective Tacey guestioned her about the timeframe regarding her drive from Studio 4 to the suspect's residence. Detective asked her to explain why it took so long for her to get there. The



Detective Tacey asked her to describe how exactly her underwear was removed. The victim stated that when was over the top of her and began to pull her dress down, he went down to his knees, and as he was going to the knees and pulling her dress, the underwear was grabbed and pulled down to her ankles, along with her dress.

Detective Tacey then questioned her about the different statements regarding penetration at the door and on the bed. Detective was referring to the sexual assault medical screening paperwork that is part of the investigation. Detective confronted her about her stating that she was not penetrated in her vagina when grabbed her by the door, but she stated that she was during the medical examination.

The victim stated she was penetrated when reached under her dress, grabbed her buttocks, and her vagina. She stated it was her belief that he placed his middle and ring finger inside her vagina, but not all the way. Detective questioned her about her previous statement that she was touched on the outside of her underwear. Detective asked her if the penetration occurred on the outside of her underwear or on the inside of her underwear, and she stated at this point that fingers went inside her underwear and penetrated her vagina.

Detective Tacey asked why there is a discrepancy in the two statements. The victim explained she thought the detective meant during his questioning at the hospital penetration required penis/vaginal insertion, and did not realize that digital penetration was part of the questioning.

Detective Tacey then asked her to clarify the statement about lying on the bed and having her vagina touched. The victim stated that was touching her vagina while she was lying on the bed and he was kissing her breast. He stated he touched her vagina and she was telling him to stop touching her. At this time she does not remember if actually penetrated her vagina with his fingers.

Detective Tacey asked the victim why she would go back to the residence after the incident that occurred with the codeine cough syrup. The victim stated she trusted him and did not think anything would happen. Detective Tacey asked if she had taken any other drugs that day. Detective referred to marijuana or any form of pills or other substances. The victim stated, "No," and then stated that she went straight to the bedroom when she got into the residence.

Detective Tacey asked if she has ever had sex with either or or and she stated, "Never."

Detective Tacey then asked her to confirm the identification of the other subjects who were there. To the best of her ability she provided the following information regarding the other potential witnesses.

Eastern for approximately a year. She has a gold car, maybe an Oldsmobile.
