Report Narrative **AUTHOR: Detective Michael Lencioni**

**INFORMATION:** On January 20, 2011, this detective was assisting Det. Tacey with witness interviews. While at [REDACTED] Ypsilanti, interviewing [REDACTED], it was learned that [REDACTED] had information regarding events surrounding the incident. [REDACTED] was present at that time and this detective conducted a brief interview with [REDACTED] in the bedroom of the apartment, while Det. Tacey interviewed [REDACTED].

**STATEMENT:** [REDACTED] explained that she just met [REDACTED] last week. On Friday, January 14, 2011, [REDACTED] said that she was present with [REDACTED] and [REDACTED] and they all proceeded to Studio 4 in Ann Arbor. She estimated that they arrived at the bar between 1130 - 1200 pm. [REDACTED] indicated that nothing out of the ordinary occurred during the evening. She said that they were all at Studio 4 consuming alcohol and socializing. During the end of the evening, around 2 am, [REDACTED] said that [REDACTED] approached her and asked if she wanted to go to a party after the club. [REDACTED] stated that she declined offer, since she did not know the guys that were supposed to be present. Ultimately after Studio 4 closed, she stated that she returned to the apartment or [REDACTED]. [REDACTED] did not accompany [REDACTED] and [REDACTED].

This detective asked [REDACTED] about the behavior and intoxication level of [REDACTED]. [REDACTED] stated that this was the first time that she associated with [REDACTED] and has nothing to compare her behavior. She explained that [REDACTED] was not stumbling or falling down. [REDACTED] added that [REDACTED] appeared to be having a good time.

[REDACTED] said that [REDACTED] then came back to the apartment on [REDACTED] at approximately 500 - 530 am. [REDACTED] stated that she opened the door of the apartment for [REDACTED] but did not have a conversation with her at that time. [REDACTED] stated that she was tired and went to bed.

When they woke up during the daytime hours of January 15, 2011, [REDACTED] said that [REDACTED] talked

about an incident from the previous evening/morning. According to [REDACTED], [REDACTED] "thought something happened to her...she didn't remember everything, just bits and pieces." [REDACTED] said that [REDACTED] told her that she remembered being at the house and that a girl (determined to be [REDACTED]) went upstairs and asked her if she was ready to leave. [REDACTED] told the girl, "No, I'm going to stay." [REDACTED] also told [REDACTED] that, "one of the guys told her [REDACTED] to say she was O.K." [REDACTED] also stated that she recalled the lights being off at times and lights on at times. According to [REDACTED] also related that she recalled, "someone holding her arms...struggling...and passing out." [REDACTED] also stated that, "one of the guys was kissin' on her and she [REDACTED] told him to stop." Upon asking [REDACTED] if she knew where the "guy" was kissing on [REDACTED] she replied, "Her breasts."

Eventually, [REDACTED] said that she accompanied Lewis to St. Joseph Hospital in the evening of January 15th.

This detective asked [REDACTED] if she knew any of the individuals that were at the house party. According to the information that she knew, she said that only one that she is familiar with is [REDACTED]

**ADDITIONAL INFORMATION:** Regarding this detective's involvement in the investigation (as of January 20, 2011), this detective was present during the search warrant executed at [REDACTED]. In addition, this detective was present during the interviews of [REDACTED] and portions of the [REDACTED] interview.
