At approximately 0215 hours on Saturday morning, 1-15-11, they were preparing to leave. The victim came up to and stated, "These are my brothers, they're good." She further stated, "They say they're about to go buy a whole bunch of liquor. Do you want to go," referring to going back to the townhouse in order to party some more and stated, "No."

explained that she had already been drinking and she did not want to go drinking alcohol with a bunch of males whom she does not know because her mom taught her that she should never go off with strangers because a bad situation could occur.

stated the victim got mad at her and asked her why she did not want to go. further explained that she had just "got into it," meaning had an argument with her boyfriend, and she was upset about that. The victim was pulling her one way to get her to go and her friend was pulling her back.

Eventually it became time to leave. stated she was still upset about having an argument with her boyfriend, and when they got out to the parking lot she realized that was not with them, as they were preparing to leave, and she stated that someone told her that she left the club with and another girl named

express concern and relayed a story regarding a barbecue party that occurred at townhouse in Ann Arbor. She stated there were a whole bunch of freshman girls over there during the springtime of 2010.

She stated the victim was the only girl there that was drinking alcohol and smoking marijuana. She observed people taking shots of 1800 (tequila) and then taking shots of Nyquil. She also observed male subjects pouring her drinks at the party.

There came a time when there was a group of the males "plotting in a huddle" in the corner of one of the rooms. She stated there were approximately 20 male subjects at this barbecue and most of them were there in the huddle. During this huddle she had heard the victim's name come up.

pot concerned because she felt that with the victim's current alcohol intake that she may have been set up to be assaulted. She had contacted the victim and stated she should leave, and the suspect "flipped out" on her, meaning she got upset and stated, "Fuck you bitch. These are my brothers."

stated she knew she had come with another male subject, identified as

The victim believes she was slipped "E," and upon questioning, the definition of "E" is ecstasy, and that caused her to pass out. The victim stated that it disturbed her, but she never went to a psychologist about it. It is stated the victim advised that she was out of school for a year because of it.
