## Report Narrative WITNESS STATEMENTS

### [REDACTED] STATEMENT

Detectives then traveled to [REDACTED] residence, [REDACTED] At approximately 1709 hours, detectives contacted [REDACTED] and she invited them into her residence for an interview.

Detective Tacey explained the investigation to her and she stated she understood. Detective asked her what had occurred that night, being January 14th into the early morning hours of January 15th. [REDACTED] stated she understood and advised that she and [REDACTED] went to the Studio 4 bar that night. The victim was already there. [REDACTED] stated she knows the victim because she used to be her resident assistant (RA) last year at Walton Dorms, Eastern Michigan University. [REDACTED] stated they all knew each other, but have not seen each other in a long time.

They stayed at the club for approximately 15 minutes after it closed. The victim came over to [REDACTED] and stated, "The boys" meaning the male subjects involved in this incident, had just texted her and let her know they were home, referring to the residence at [REDACTED] [REDACTED] asked [REDACTED] and [REDACTED] if they wanted to go over the residence and they stated they would.

They left the bar and the victim drove [REDACTED] vehicle. [REDACTED] estimated they left the club at approximately 0230 hours, but did not get to the suspect's residence until approximately 0250 hours. Detective asked why it took so long, and she first stated that she did not know, but then she thought for a second and stated they got lost. She advised they ended up at a gas station first and the male subjects met them at the gas station.

They arrived at the suspect's residence and [REDACTED] and [REDACTED] entered and sat on the couch. in the living room. The victim went upstairs. [REDACTED] and [REDACTED] were sitting on the couch for approximately 15 minutes, when [REDACTED] stated, "Where is this girl at?"

[REDACTED] then went upstairs to knock on the door and did not get an answer, but later stated to [REDACTED] that she heard them talking. [REDACTED] came back downstairs and talked to [REDACTED]

They were talking about what was going on upstairs and the victim not answering. The discussion came to the point where they thought the suspects "ran a train on her," meaning that multiple subjects were having sex on her at the same time.

██████████ told ██████████, "We're about to go because we're not sitting down here for this," meaning that she did not want to hang out in a strange residence while their friend was upstairs having sex. ██████████ stated that when ██████████ went back upstairs a second time to knock and no one answered.

At this point Det. Tacey steered the questioning to a time when the victim may have come down to get her phone.

██████████ thought long and hard. She thought maybe she did come down, but then she could not remember. Detective Tacey attempted to clarify, and asked if she knew whether it was before ██████████ went upstairs, after ██████████ went upstairs the first time, or after ██████████ went upstairs the second time. She thought some more and she stated she thinks the victim yelled downstairs and said she needed her phone and asked ██████████ to get her phone for her.

She also thought this may have occurred after the first time that ██████████ went upstairs.

She cannot remember ██████████ handing the victim her phone and thought this was approximately 20 minutes after they first got there.

Because of her lack of memory detective asked if she was intoxicated. She first indicated no, but on further discussion she stated, "Kind of," and "a little but functional."

Upon questioning, ██████████ stated she cannot remember if she went upstairs or not. Detective asked if she drank anything while she was at the residence and she stated no.

Detective Tacey asked if she smoked anything while at the residence, and she stated no.

Detective asked if she had any other form of controlled substances while at the residence, and she stated no.

Detective asked how long she was at the residence, and she stated, "Long time, maybe there 40 minutes." She then indicated that she got home at approximately 0400 hours.

Detective Tacey asked if she saw anyone with an 1800 (tequila) bottle. She stated she did and it was a light-skinned black male who had it. She did not drink out of it.

Detective Tacey asked who she knew at the residence. The only person she knew was the person by the name of ██████████. She knows him from around the Eastern Michigan University campus area. She does not know his real name.

Upon questioning, detective asked if she knew whose house she was at, and she did not know.

The conversation turned back to being at the residence with the victim. ██████████ stated that when they went there ██████████ believed the victim "wanted it." Upon further conversation about "it," ██████████ defined it as consensual sex.

Later on, in conversations between ██████████ and ██████████ they were stating, "I can't believe she brought us all the way over and had a train ran on her."

Detectives asked her about her history/knowledge of the victim.

██████████ stated she was her resident assistant last year at the dorms. She knows that the victim

had fought with girls on campus that did not like her, and specifically stated she had fought in eateries. The reason she fought with these girls is because they felt she was talking to their boyfriends.

██████████ also knows that the victim has been kicked out of clubs/bars over the weekends for fighting.

██████████ stated the victim has a reputation of being a "ho." Upon inquiring as to the definition of a ho was to ██████████, she stated the victim has "slept with half the football team." ██████████ then explained that the dorm she was an RA in and that the victim lived with was a sports dorm and the victim had "sex with everybody," which by the way she delivered the statement caused the detective to believe she was exaggerating for dramatic effect.

██████████ also stated she had a lot of "boys" in her room. Upon questioning if she knew for a fact that she would have sex with these male individuals, she stated, "I know at least three football team players had sex with her."

Detective Tacey asked if she would recognize the people who were at the residence. ██████████ indicated she would, but she does not know any of their names.

Detective Tacey asked if she has talked to the victim since this, and she stated she has not, but she has talked to ██████████ regarding it.

Detective Tacey asked if she talked to any of the male subjects who were at the residence during the time of this incident, and she stated she has not, but she did see ██████████ at the gas station yesterday and she just said hi to him.

Detective Lencioni asked if she heard any noises upstairs during the time the victim was up there, and ██████████ stated no.

██████████ stated that ██████████ told her that she heard them, referring to the people inside the bedroom, say something about some money. ██████████ stated, "He said how much do I need to give you," believing they were talking about money.

Because of some inconsistencies between her statement and the other witness and victim statement, and some gaps in her memory, Det. Tacey again talked to her about how much she had to drink. During this conversation it was agreed upon that her memory may have been affected by the alcohol that she drank at the club.

Detective Lencioni asked ██████████ about appearance. ██████████ indicated the victim appeared to be drunk, but she was a happy drunk and kind of "hyper."

Detective Lencioni referred back to the victim's driving. ██████████ stated she was scared for the victim's driving and she "didn't do good." She stated that when the victim pulled out the parking structure, the car turned and swerved and she had to readjust it in order for it to go straight. She further stated they still got lost as they were traveling to the suspect's residence.

Detective Lencioni inquired about how she was walking, and ██████████ stated she was stumbling, but she did not fall down.

Detective Tacey asked about her cell phone and he was not able to contact her. She stated her cell phone is currently disconnected, but she will be repaying her bill to have it activated again. She stated her cell phone number is ██████████

Detective Tacey then provided her with his business card and asked her to call him if she had any
