Investigation into this incident continues.

STATEMENT OF ██████████

At approximately 1114 hours, Det. Tacey received a telephone call from ██████████ reference this incident. He advised that he found out that the detective had been attempting to contact him and wanted to make a statement regarding this incident.

Det. Tacey advised him it was regarding the incident under current investigation and ██████████ stated he understood and remembers.

Det. Tacey asked who he was with and he indicated he was with ██████████ and ██████████. Upon questioning, ██████████ stated that there was another subject there whom he does not know, and is a cousin or friend of ██████████ and another subject whom he knows as ██████████, also known as ██████████, but he doesn't really know him.

During the night, the group went to the Fifth Quarter Bar. They then later went to Studio 4.

While at Studio 4, he observed the victim ██████████. She was at a table and she went up to

talk to them. He stated she was "drunk" and on further discussion of how drunk she was, he stated she was "super" drunk.

He described her as sitting at the table with her "dress all up" meaning that it was riding high on her legs to the point of where it would be inappropriate.

██████████ went and talked to her and advised that he is "cool with her". He was telling her to put her dress down and to get some water to drink because she was intoxicated. He advised that he knows her through school, that being Eastern Michigan University. He stated shortly thereafter he left her and they left the bar.

A short time later they went to the gas station and ██████████, along with ██████████, whom he knows used to run track at Eastern Michigan University and ██████████, who works at EMU as a student aid, pulled up into the gas station. ██████████ was driving.

██████████ stated he stayed in the car, ██████████ got out and went into the gas station. A short time later they left the gas station and the girls followed them to ██████████'s house. He doesn't know exactly where ██████████ residence is located at.

He stated he traveled in ██████████ car and once they got to the residence, they parked in the garage and entered through the garage door and into the residence.

He stated that everybody was hanging out in the living room, there were all the males and the three females, they were just "talking and chilling".

Eventually ██████████ and ██████████ went upstairs.

When detective questioned him about the timeframe after they got to the residence, he indicated he did not exactly know and estimated 5 or 10 or 15 minutes.

██████████ further stated ██████████ "she was good" and "not as drunk" as she was earlier in the evening.

Eventually ██████████ states that he goes outside to smoke some Marijuana and ██████████ goes to the car with him.

Det. Tacey advised ██████████ that he has talked to many subjects regarding this case and obtained several witness statements, including ██████████ and that his current statement does not correspond with what the other witnesses are stating.

██████████ stated he believes that ██████████ came out to the car later. He then stated at one point ██████████ did go upstairs and later came to the car.

Det. Tacey asked what did ██████████ talk about when he went upstairs and he stated that ██████████ told him "nothing, he couldn't get in the room." He then indicated that ██████████ and ██████████ were in the upstairs guest bedroom so ██████████ came down the stairs.

██████████ also stated "her girls left her," referring to ██████████ and ██████████ leaving ██████████ there.

██████████ explained that ██████████ has a "bad reputation," that being with several male subjects. ██████████ explained, "they (the other two females) figure we try and lay down with them," meaning the girls thought that ██████████ brought them to the residence so they could have sex with the other subjects who were there and the girls did not want any involvement with that situation.

Det. Tacey asked if he knows what time the other girls left and he stated he didn't know what time.

Eventually [REDACTED] and [REDACTED] came down and she stayed there.

[REDACTED] stated, "I was the first one to leave," and he doesn't remember what time he left.

Upon questioning, he does not remember [REDACTED] teasing her about being with two male subjects.

Det. Tacey asked how much alcohol he had to drink. [REDACTED] stated he didn't drink alcohol, he was just smoking Marijuana.

Det. Tacey asked about the 1800 Tequila bottle, and he does not recall it.

Det. Tacey asked about [REDACTED] taking pictures with her cell phone. [REDACTED] stated he does not know of any pictures taken during this incident.

Det. Tacey again talked about the fact he was stating that [REDACTED] came out to the car and he stated that he really did come out to the car after he came down from upstairs.

Det. Tacey asked what did he ([REDACTED]) say when he got to the car. [REDACTED] stated that [REDACTED] told him that [REDACTED] was in the room with [REDACTED] and "they were talking." [REDACTED] didn't say anything about sex and stated he could not get into the room.

Det. Tacey asked if he had talked to [REDACTED] since this had occurred and he stated no, he hasn't heard from [REDACTED] since this happened.

[REDACTED] stated the only person he has talked to is [REDACTED]

Det. Tacey asked what did he say. [REDACTED] stated that if the police call him he is to call back and talk to them. He stated he hasn't talked to anybody else regarding this matter and he hasn't called [REDACTED]

Det. Tacey asked if while he was in the residence he heard any yelling or screaming and he stated he didn't. He stated that even when she came down, she was not crying or emotional and was not acting like she had been violated. He stated she was laughing with everybody.

The interview with [REDACTED] ended at approximately 1134 hours.

STATEMENT OF [REDACTED]

Det. Tacey and Det. Lencioni traveled to the residence of [REDACTED] and [REDACTED] where they contacted [REDACTED] who was at the residence. [REDACTED] stated that [REDACTED] currently was gone, but he would attempt to contact him and did so by way of text. At approximately 1309 hours, Det. Tacey telephoned [REDACTED]. [REDACTED] stated he was almost to his residence and that he would talk to the detectives upon his arrival. [REDACTED] arrived a short time later and did not have a key to get into the outer door, so Det. Tacey went down and let him in.

Upon questioning, it was determined that [REDACTED] would go out and wait in the vehicle in the parking lot while the detectives interviewed [REDACTED] in his dining room in his apartment.
