Det. Tacey asked if he knows what time the other girls left and he stated he didn't know what time.

Eventually [REDACTED] and [REDACTED] came down and she stayed there.

[REDACTED] stated, "I was the first one to leave," and he doesn't remember what time he left.

Upon questioning, he does not remember [REDACTED] teasing her about being with two male subjects.

Det. Tacey asked how much alcohol he had to drink. [REDACTED] stated he didn't drink alcohol, he was just smoking Marijuana.

Det. Tacey asked about the 1800 Tequila bottle, and he does not recall it.

Det. Tacey asked about [REDACTED] taking pictures with her cell phone. [REDACTED] stated he does not know of any pictures taken during this incident.

Det. Tacey again talked about the fact he was stating that [REDACTED] came out to the car and he stated that he really did come out to the car after he came down from upstairs.

Det. Tacey asked what did he [REDACTED] say when he got to the car. [REDACTED] stated that [REDACTED] told him that [REDACTED] was in the room with [REDACTED] and "they were talking." [REDACTED] didn't say anything about sex and stated he could not get into the room.

Det. Tacey asked if he had talked to [REDACTED] since this had occurred and he stated no, he hasn't heard from [REDACTED] since this happened.

[REDACTED] stated the only person he has talked to is [REDACTED]

Det. Tacey asked what did he say. [REDACTED] stated that if the police call him he is to call back and talk to them. He stated he hasn't talked to anybody else regarding this matter and he hasn't called [REDACTED]

Det. Tacey asked if while he was in the residence he heard any yelling or screaming and he stated he didn't. He stated that even when she came down, she was not crying or emotional and was not acting like she had been violated. He stated she was laughing with everybody.

The interview with [REDACTED] ended at approximately 1134 hours.

## STATEMENT OF [REDACTED]

Det. Tacey and Det. Lencioni traveled to the residence of [REDACTED] and [REDACTED] where they contacted [REDACTED] who was at the residence. [REDACTED] stated that [REDACTED] currently was gone, but he would attempt to contact him and did so by way of text. At approximately 1309 hours, Det. Tacey telephoned [REDACTED]. [REDACTED] stated he was almost to his residence and that he would talk to the detectives upon his arrival. [REDACTED] arrived a short time later and did not have a key to get into the outer door, so Det. Tacey went down and let him in.

Upon questioning, it was determined that [REDACTED] would go out and wait in the vehicle in the parking lot while the detectives interviewed [REDACTED] in his dining room in his apartment.

[REDACTED] stated that he understood the timeframe in which the detectives were questioning him and he knows about the incident investigation. He is also [REDACTED] roommate.

Det. Tacey asked him to advise what occurred and who he was with. [REDACTED] indicated that on the night of the investigation he was with [REDACTED], [REDACTED], and [REDACTED]. Later it was determined that there was another subject there whom he does not know.

He stated they were out driving around in [REDACTED] car.

They first went to the Fifth Quarter and then they went to Studio 4. He stated they began driving about 0100 hours and then arrived at Studio 4 at approximately 0130 hours.

Upon arrival at Studio 4 he stated that the club was "almost empty" referring that there were not a lot of people there. He did observe the victim, whom he knows as [REDACTED] in the club. He stated that upon seeing the group she was happy and she began crying. Upon questioning, it was later determined that it was a happy cry because she has not seen the group in a long time, but [REDACTED] described her as being "drunk."

[REDACTED] indicated to him that they have not called or talked in a long time, she was hugging and kissing him on the cheek, and later she was talking about how it's been hard in life and how people aren't helping her out by giving her money.

[REDACTED] states they were there for approximately 15 to 20 minutes. As they were leaving, she began to hug everybody again.

They left the club and as they were driving around, somebody was talking to her on the phone, but he does not know who. It was agreed upon that she was going to go and meet them at [REDACTED] residence.

They then began driving around downtown Ann Arbor to see who's out and what's going on, for approximately 10 minutes.

They eventually met at the gas station, which he described as a Shell gas station on the corner of Ann Arbor-Saline. They were there for about 5 minutes, went into the gas station, and the victim was with them and somebody ended up buying her some chips.

They then returned to the parking lot where they drove to [REDACTED] residence and the girls followed.

[REDACTED] parked the car in the garage and the girls parked behind them in the driveway.

Upon questioning on who the victim was with, it was determined that she was with a girl whom he knows from school as [REDACTED] and another dark skinned girl with short hair whom he does not know. [REDACTED] was driving the car.

Upon arrival at the residence, he stated they were just "chillin" in the living room and hanging out.

Upon questioning he believes that this was at approximately 0300 hours. During that time they did order a pizza.

At approximately 0315 hours, he decided to go out and smoke some Marijuana and stated he was out

there for approximately 15 minutes when [REDACTED] and [REDACTED] came out. The girls stayed inside the residence.

During this time he was told by the two subjects that [REDACTED], [REDACTED], and [REDACTED] were upstairs.

Approximately 5 minutes later, the girls were leaving and he asked, "Where's [REDACTED]?" They indicated to him that she was still upstairs.

He returns into the residence and he goes upstairs. He then observed that the guest bedroom to his right at the top of the stairs is closed. He goes up to the closed door to listen in on what's going on inside the bedroom. [REDACTED] states he hears the three of them talking, he hears [REDACTED] saying, "Let's go to the shower ya all, that sounds like fun."

He stated that the two male subjects inside "weren't trying to do that," referring to they didn't want to go into the shower.

He then hears [REDACTED] tell them both to take their clothes off and the male subjects were resistant to that.

He then heard [REDACTED] "only wanting to do it (sex) to [REDACTED]."

Det. Tacey defined "it" in the way that [REDACTED] used is as having sexual intercourse.

[REDACTED] then stated, "She said you both can if you don't use condoms," referring to having sexual intercourse with her.

This lasted about 5 minutes of [REDACTED] listening at the door and then he goes downstairs and outside.

Approximately 5 minutes later he receives a call from [REDACTED], asking where he is at. He tells [REDACTED] that he is in the car and that he should stay in the house because he will be in shortly.

He comes back into the house, into the living room, and eats some pizza.

At this time he is told by [REDACTED] that [REDACTED] and [REDACTED] are upstairs with the door closed. [REDACTED] stated that [REDACTED] has done something like this before at a cookout in their residence near [REDACTED]. [REDACTED] got drunk and was upstairs with a subject whom he identified as [REDACTED]. She later started screaming and crying, "you raped me," but later relaxed and still was hanging out with [REDACTED].

Det. Tacey asked what did [REDACTED] tell him about what happened upstairs. [REDACTED] stated [REDACTED] said, "She wasn't budging," meaning that she did not want to have sex with [REDACTED], but she stayed up there with [REDACTED].

Det. Tacey asked if [REDACTED] went up there in order to have sex with [REDACTED] and [REDACTED] stated he doesn't know what he was up there for, but he assumed he was up there in an attempt to have sex.

[REDACTED] stated they came down in approximately 5 minutes and that she was acting like a "crazy groupie". She wanted [REDACTED] to introduce her to [REDACTED].

[REDACTED] then stated that they began to tease each other. [REDACTED] called [REDACTED] fake and that he never calls her anymore.

[REDACTED] started teasing her that she is Kat Stacks. Upon defining what he means its in relation to a known hip hop model who has sex with several well known hip hop artists. [REDACTED] stated that

his teasing went back and forth for about five minutes.

Det. Tacey asked [REDACTED] if [REDACTED] was mad at him for this teasing and he stated no, that it was a normal argument they are having.

Det. Tacey asked [REDACTED] if he stated that he was going to place [REDACTED] on World Hip Hop Internet and he stated no.

Det. Tacey asked [REDACTED] if [REDACTED] took any pictures with her phone, and he indicated that she didn't.

He stated that [REDACTED] then stated who's going to take her home and the guys stated, "Not us."

[REDACTED] stated that [REDACTED] then stated, "I'm going to spend the night." [REDACTED] stated, "no you're not."

[REDACTED] states he left at approximately 0415 hours, he's not exactly sure what time [REDACTED] left, or who took her home, but he did hear that she had to go to [REDACTED] residence in order to get her keys.

Det. Tacey asked how much he had to drink that night. He stated he had two shots of 1800 Tequila poured into a glass with cranberry juice because he does not drink shots straight. He drank this before he went out to the clubs, and he did not finish his whole drink.

Det. Tacey asked who brought the 1800 Tequila bottle and he stated that [REDACTED] did.

Det. Tacey related the story about a subject going up and giving 1800 Tequila shots to people up in the room and [REDACTED] stated that it did not happen.

Det. Lencioni asked [REDACTED] if anybody had taken advantage of [REDACTED] and [REDACTED] responded, "No, [REDACTED] knew what was going on," meaning that [REDACTED] knew she was coming over to hang out with the subjects.

Det. Lencioni asked [REDACTED] what does [REDACTED] do in order to cause problems and [REDACTED] stated that [REDACTED] causes constant drama within the black population at Eastern Michigan University. Most of the time it is "beefing" over a subject, meaning that she may cause problems when she attempts to be with, or have sex with other girlfriend's boyfriends.

[REDACTED] stated that [REDACTED] is a smart girl and used to help him with his homework, but she is always "messing", on further definition meaning sex, with other dudes and that she has lost her mind.

He states that he is good friends with [REDACTED] and that he learns about her having sex with other male subjects because she tells him that she has sex with these male subjects.

Det. Lencioni asked [REDACTED] if she ever said she had sex with [REDACTED] and [REDACTED] stated, "No, never."

Det. Lencioni asked if she ever had sex with [REDACTED] and [REDACTED] stated, "Yes, last year," but then followed up by stating it's a rumor they had intercourse last year.

Detectives asked [REDACTED] who he has talked to reference this incident. He stated he was talking to [REDACTED] because they are roommates. He also stated he has talked to [REDACTED] twice, they have not discussed the particulars of the incident, but [REDACTED] was asking him "why's she doing this?" He said he hasn't discussed what happened because [REDACTED] has been at his parents since this

occurred and that he would not talk about it around his parents.

Det. Lencioni asked what [REDACTED] opinion is of why she is making this report. [REDACTED] stated that he believes [REDACTED] "wants some money." He then follows up by stating it is no secret who [REDACTED] is, and it's no secret whom his father is. He also referred back to the time when [REDACTED] told [REDACTED] "Introduce me to [REDACTED] and we'll be okay."

Det. Tacey asked [REDACTED] if he had ever said anything similar to introducing her to a Michigan State University basketball player by the name of [REDACTED]. [REDACTED] stated that the biggest name in sports that he knows is his friend [REDACTED] who plays basketball for Michigan State University and that he jokingly told her that he would introduce him to her.

Det. Tacey ensured that [REDACTED] had his business card in case he had any questions or information later on.

The interview ended at approximately 1348 hours.
