



I informed Christie the incident under investigation occurred after the University of Michigan versus Ohio State football game on December 1. He stated the other incident occurred two to three weeks before that incident, stating he was almost certain it was after the Iowa State football game.

Christie stated they were leaving Scorekeeper's Bar, and stated a friend had made reference to the U of M loss to Taylor Lewan, with Lewan then pushing his friend. He stated he had witnessed what had occurred. I asked where Lewan had pushed his friend, and he stated he was not comfortable speaking with me without first speaking with his father, and the friend.

Christie returned a telephone call to me, stating again it was nothing and they did not want to pursue the incident. I informed him that some of the information may be relevant to the current case under investigation, but no one was requesting that they pursue prosecution.

Christie stated the subject involved with speak with me, and provided a name of Jesse Weiss, with telephone number [REDACTED]

### CASE REPORT

#### Ofc. Monroe

This is a non-priority follow-up. Case #13-58729. Reporting: Officer Monroe, Badge 500. Incident type: Aggravated Assault.

#### FOLLOW-UP INVESTIGATION:

#### CONTACT WITH ALEX DILEO:

At approximately 11:40 am on 1/29/14, I made telephone contact with an Alex Dileo out of Louisiana. I informed Dileo I was attempting to reach an Alex Dileo who had dated Taylor Lewan. She stated, "This is she." I inquired as to whether they are currently dating and she stated that they are not.

I informed Dileo that I was sure she was aware, based on media attention, of the investigation concerning an incident on South University Street and Taylor Lewan. She stated she was familiar with the incident.

I informed Dileo that I had interviewed several subjects, had a recording of much of the incident, stated I wanted to get her perspective.

#### DILEO'S STATEMENT:

Dileo stated it was the night after the Ohio State game. She stated they were all getting out of the cab, and stated, "Me and Taylor were out of the cab," and Bryce (Taylor's brother) was "taunting" an Ohio State fan.

Dileo stated to Taylor, "Your brother is about to get in a fight." She stated Taylor (Lewan) turned around, and jumped on the guy.

I asked her what Bryce did, and who started it. She stated it was verbally going back and forth. She stated



Bryce started going after the guy. She stated it became physical before Taylor got there. She stated from her recollection, and what she knows of Bryce, she thought he was going to get in a fight again.

She stated that based on the initial going back and forth, it should not have been necessary to fight. She stated everyone was drinking, the Ohio State guys were walking around, people were having a good time, and they were planning on going to the bar. She stated nothing was being said to Taylor, and not until Bryce got into a fight did it become a problem.

Dileo went on to state she felt like the whole reason everything happened was that she told Taylor that his brother was in a fight. I asked Dileo to describe the situation with Bryce further.

She stated she heard yelling, Bryce was kind of going after the guy, and then a bunch of guys were grabbing people to get people off. She stated she knew they were (physically) fighting and that's when she turned to Taylor.

I asked about the taunting, and she stated Bryce was in his face. She stated Taylor didn't hesitate, and was getting into the fight. She stated that not long after, it was broke up.

Dileo started to express concern that people would feel what she was saying was because of Taylor being her ex-boyfriend, as though she was getting back at him. She stated she knows what happened and Taylor is lying. She stated he got the guy on the ground, and came back at him.

I explained to Dileo that she has an obligation to tell the police the truth, and if she were to lie to me, she could be charged with a crime. I informed her that I was telling her that information not as a threat, but so that she understood her obligation regarding the incident.

Dileo continued by stating, "He knocked the guy to the ground and he punched him," referring to Taylor. I asked about the subject on the ground, and she stated she could not remember his face. She stated she knows he was with at least one other guy, they were a little older than them, but not old. She stated maybe in their late 20's. She stated Taylor's back was to her.

Dileo stated Bryce was in the fight, Taylor jumped in, and punched the guy. She stated the circle then cleared out, and the guy was on the ground.

I asked about Taylor striking the subject after he was on the ground. She stated he did not from what she remembered. She stated it happened fast, but she did not see Taylor keep on punching him.

Dileo stated it cleared out, Taylor said "Let's go to the bar," and they walked in and it was packed. She stated when he walked in, he said to Jack Greenlee, "I just decked a guy out there." I asked if Greenlee was a football player, and she stated he was not, and she believes he ran track.

I asked about anyone else that he had made that statement in front of. She stated she is trying to remember who else was there. She stated he had a friend in town that weekend, but Jack (Greenlee) was the first person he saw when they walked in, and was the first time she heard him say something about it. She stated she became separated from Taylor while in the Brown Jug, and then when she next saw him he was outside talking with the police.

Dileo stated she could see that he was in a fight and punched someone, and then he stated, "I knocked a guy out, I decked someone." She stated that she was pretty shocked when he was saying he didn't do it





because it was a known thing.

She stated that at breakfast the following the morning, he was telling his mom. She stated "I know he knows he did it." She stated he said to his mom that he was defending Bryce, and he knocked a guy out. I asked if that's what he said to her, and she stated she wanted to make sure she was correct, and knows when he was describing it, the gist that it would imply that.

I asked Dileo if there were other people he said it to. She stated that at breakfast they were with Mike Schofield's siblings. She did not believe Schofield was out there when it happened, but may have been in the bar. She again stated she did not think he was outside.

Dileo described the incident had occurred next to the Brown Jug where it was more lit up. She stated she was near the door of the Brown Jug, saw his back, and saw him swing, and then saw the guy on the ground.

Dileo stated she did not know if we would contact her, but knew she would tell the truth if we did. She stated she has known he is lying, but broke up, and was not there to rat him out.

I asked Dileo if the reason for the breakup was the incident. She stated it was not specifically this incident, but stated he lies a lot. She stated that when he lied about what happened, and then because of before, it was the final straw.

Dileo stated she has resided in Ann Arbor from June until December (2013), and then the end of December went back to Louisiana. She believes they broke up around Christmas.

I again asked her about who started the physical confrontation between Bryce and the other subject. She stated she could not say who started it, but stated if he (Bryce) didn't, she was concerned he was going to.

I asked Dileo about Lewan's parents. Dileo stated Dave Lewan and Kelly Riley are Taylor Lewan's parents. She stated that regarding his parents, she believes only his mother (Riley) was at the breakfast. She stated Taylor was not talking to the whole table, but was telling his mom what he had done. She believes his friend Nick was present, and was not acting surprised by what he was telling his mother. She stated she knows Nick knows the truth.

I obtained a telephone number for Kelly Riley of [REDACTED]. I obtained address and contact information for Dileo, with my interview ending at approximately 12:18 pm.

### CASE REPORT

This is a non-priority follow up to 13-58729. Time is 0900 hours, date of 02/18/14. Reporting Officer Monroe, Badge 500. Incident type: Aggravated assault.

#### FOLLOW UP CONTACT WITH VINCENT PORTER (SCHOFIELD'S ATTORNEY):

On 02/07/14, I again spoke with Porter. Porter informed me that he had again spoken with Michael Schofield, who stated they had not attended breakfast the following morning with Lewan's family, with



Schofield recalling he and his sister had gone to Men's Warehouse.

FOLLOW UP CONTACT WITH ALEX DILEO:

On 02/12/14, I spoke further with Dileo by telephone. I reviewed certain information with her at that time.

I spoke with her regarding Schofield having siblings in town that weekend and being at breakfast the following morning. She stated she knew that his siblings were in town but did not recall them being at breakfast the following morning. She apologized if there was misunderstand during our initial interview.

I spoke with her about my conversation with Greenlee. Dileo stated she knows for certain they had contact with Greenlee at the Brown Jug, and stated they "just happened upon him." She stated she cannot say whether he was drinking a lot concerning his memory of there contact.

I asked Dileo about her alcohol use that night. She stated she had been drinking earlier at Lewan's house, but had not had as much as Lewan.

Regarding breakfast on the following morning, she recalled it was at Café Felix; she, Taylor (Lewan), Nick, Bryce, and Lewan's mom were present. She stated his mother also had some of her friends there. She stated Schofield and siblings were at the bar the previous night, but she does not believe they were outside at the time of the incident. She stated they were definitely not at the breakfast.

She stated that she did not want to say Schofield for certain knew what had occurred, but again stated Lewan was not hiding it at the time.

ATTEMPT CONTACT WITH NICK BENNETT:

As of 02/18/14, I have left two telephone messages for Nick (believed to reside in the state of Colorado), with no return telephone call from him.

ATTEMPT CONTACT WITH LEWAN'S MOTHER:

I have made two telephone calls to Lewan's mother's telephone number, requesting a return telephone call to me but not leaving my title. I have not received a return call from her.

MEDICAL INFORMATION:

-

On 2/18/2014, I reviewed further with Ryan Munsch medical treatment information. Munsch informed me Hughes was not treated at the scene or at the hospital regarding the assault against him.

Munsch stated he was transported to U of M due to having been struck in the head and due to falling. He also stated he was having some problems breathing properly from having been struck in the ribs.

Munsch stated he would forward his discharge papers and his follow-up report (OSU) to me through email.

-

On 2/19/2013, I emailed a medical release form to Munsch, which he signed and returned to me through email. I forwarded the signed release form to the U of M Health System.
