Attempted Armed Robbery

LOCATION:

University of Michigan Hospital cafeteria kitchen room #2D350, 1500 East Medical Center Drive, Ann Arbor, MI 48109.

REPORT RECEIVED:

I responded to the above location at the report of an attempted robbery with an unknown weapon involved. The suspect was described as a black male with dread-lock style hair wearing a white shirt and dark pants, last seen running from the south Mott entrance of the hospital complex towards Observatory Road.

OFFICER ACTIONS:

I responded to the area on north bound Observatory Road. The suspect was not observed in the area. I made contact with Hospital Security staff and witnesses near the Mott Hospital location on E. Hospital Drive. Witnesses at this location provided suspect descriptions and advised the suspect fled on foot from this area toward the direction of Observatory Road. I notified K-9 Officer Dunny of the location where the suspect was last observed running. I met officer Dunny at this location and provided cover while the K-9 began to track the suspect. The track ended in the area of Observatory Road and Ann St. I returned to the hospital and met with the victim who was currently receiving treatment for injuries in the Emergency Room.

WITNESS INTERVIEW: Philemon Padonou

Padanou was identified near the south entrance of Mott Hospital on E. Hospital Drive. Padanou identified himself as an employee of Aramark working in the Hospital cafeteria as a supervisor. Padanou stated he witnessed the suspect run out of the hospital heading south towards Observatory Road. Padanou stated he witnessed the suspect remove a yellow color hooded shirt as he ran. Padanou stated the suspect was observed to be wearing a white shirt that had buttons up the front and a collar and black pants. Padanou stated the suspect did not throw away the yellow shirt, he carried it as he ran away.

Padanou provided his contact information for follow up interviews with investigators.

WITNESS INTERVIEW: James Jordan

Jordan was identified near the south entrance of Mott Hospital on E. Hospital Drive. Jordan identified himself as a UofM Hospital employee. Jordan stated the suspect "almost took me out" when he ran past him at this location. Jordan stated he observed the suspect to be wearing a white t-shirt with no collar and no buttons. Jordan stated the suspect was also wearing a dark pair of blue jeans. Jordan described the suspect as a black male approximately six feet tall.

Jordan provided his contact information for follow up interviews with investigators.

VICTIM INTERVIEW: Neil Crawford Galbraith

I met Galbraith in the UofM Hospital Emergency Room patient bay #16. I observed that Galbraith had injuries on his head and right hand. I took photos of Galbraith's injuries while he remained in the hospital for treatment. See the photo log for details. Galbraith was receiving treatment from UofM Emergency Room physicians Pamela Fry M.D., and James Pribble M.D.

I conducted an interview of Galbraith while he remained in the hospital receiving treatment for his injuries. Galbraith identified himself as an Aramark employee, working as the Cash Office Supervisor in the cafeteria since June of 2010. Galbraith stated his schedule is Monday through Friday from 1:30pm until 10:00pm each day. Galbraith stated his responsibilities include delivering at total of 16 cash drawer bags ranging in amounts from \$300 to \$500 every Friday evening to the cafeteria managers office and to the Einstein Brother restaurant office located near the entrance of the cafeteria.

Galbraith stated he began making the cash deliveries at approximately 18:30 hours this evening. Galbraith stated he delivered 11 cash bags to the manager's office without incident. Galbraith stated he proceeded into the kitchen area behind the Einstein Brothers restaurant to

gain access to the office when he was attacked. Galbraith stated he pushed a hand cart carrying the cash bags into the kitchen area and parked it near the food preparation counter. Galbraith stated as he picked up the cash bags to carry them into the office he noticed a subject emerging from the hallway near the Einstein Brother's office. Galbraith stated this subject began to move quickly towards him in a slight crouch as if he was going to tackle him. Galbraith stated he observed this subject was wearing some type of mask over his face and was carrying what appeared to be a stun gun in his right hand. Galbraith stated the object in the suspect's right hand was small and black, approximately the size of a remote control garage door opener. Galbraith stated he observed the object in the suspect's hand light up with sparks and he heard it make a crackling type of sound.

Galbraith stated he was holding all five remaining bags of cash as the suspect charged at him. Galbraith stated he braced himself and turned his shoulder toward the suspect. Galbraith stated the suspect hit him and knocked him to the floor. Galbraith stated he felt a sharp pain from being struck in the left side of his back. Galbraith stated his glasses were knocked off his face and the cash bags were knocked out of his hands. Galbraith stated he began looking for his glasses and the cash bags when he noticed the suspect standing over the top of him while he remained lying on his side on the floor. Galbraith stated he began shouting as loud as he could to get attention and get some help. Galbraith stated he then felt something strike him in the head. Galbraith stated he continued to shout and he grabbed on to one of the suspect's legs and held on with both arms. Galbraith stated he continued shouting and felt another strike against his head. Galbraith stated he believes the suspect kicked him in the head. Galbraith stated he released the suspect's leg after being kicked in the head. Galbraith stated the suspect then ran out of the kitchen door into the cafeteria exit hallway. Galbraith stated he was still on the floor a moment later when his co-worker Phil Padonou entered the kitchen through the same door the suspect had just ran out of. Galbraith stated Phil asked him "Did you hear that?". Galbraith stated he immediately told Phil that he had just been "jumped" by a guy that just ran out of the door. Galbraith stated Phil proceeded to run down the hallway after the suspect.

Galbraith stated he then found his glasses on the floor and collected all five cash bags from the floor. Galbraith stated returned to his office with the cash bags and intended to call Hospital Security. Galbraith stated he was met in the area of his office by another employee and he directed the employee to call security for assistance. Galbraith stated he was met by security at his office and he reported the incident. Galbraith stated he was then escorted to the emergency room for medical treatment.

Galbraith described the suspect as a black male, unknown age, approximately 5'9" to 5'10" with a medium build. Galbraith stated the suspect was wearing something like a mask over his face, covering his mouth. Galbraith stated he could not tell if the suspect was wearing a ski mask or a scarf like piece of clothing over his face. Galbraith stated he believes the suspect was wearing black sunglasses and possibly a hat on his head. Galbraith stated he believed

the suspect had a few inches of dread-lock style hair dangling off the back of his head. Galbraith stated the suspect was wearing a dark colored "hoodie" style sweatshirt or jacket. Galbraith stated he believed the suspect's jacket possibly had some kind of vertical pattern or straps over the shoulders and on the front. Galbraith stated the suspect was wearing dark blue or black colored jeans. Galbraith stated he did not see the suspect's face because it was covered with some type of mask. Galbraith stated he did not remember hearing the suspect's voice, and does not believe the suspect said anything to him.

After Galbraith was discharged from the hospital as a patient in the emergency room, I escorted him back to the scene in the cafeteria. Galbraith returned to his office, room #2D335, and confirmed all five cash bags were secure. Galbraith's supervisor confirmed all of the cash was accounted for. Galbraith demonstrated the path he took to deliver the cash through the kitchen in the back office area of the Einstein Brothers restaurant. Galbraith entered the kitchen through door #2D350. Galbraith identified the kitchen area where he was attacked and knocked down on the floor. Officers at the scene observed a dread-lock style hair piece on the floor in this area. See Officer Zavala's report for evidence collection information. Galbraith identified kitchen exit door #2D345 as the door the suspect fled through after the attack.

Galbraith stated his supervisor Josh Burk has been notified of this incident. I provided Galbraith with my business card and this report number. I also provided Galbraith with a second card to offer his supervisor.

VICTIM'S RIGHTS INFORMATION:

I issued to Galbraith a Victim's Right Information card.

While on patrol I was dispatched to the area of the south doors to MOTT hospital where a suspect in an armed robbery had fled the scene. I arrived and advised Sgt. Soichet if I was clear to deploy K9 and he approved.

K9 DEPLOYMENT:

I retrieved my K9 partner Tazer from my K9 vehicle and took her to the area where the suspect was seen running away. I started Tazer tracking at the southeast corner of Simpson circle and E. Hospital drive. I gave Tazer the command to track and she immediately picked up a sent and began tracking. Tazer tracked west across Simpson circle to a grassy strip between the sidewalk and the parking structure. Tazer then tracked south to a set of stairs heading west bound. Tazer tracked up the stairs to the bus shelter on the east side of Observatory in front of the Simpson Building. Tazer lost the track at the bus shelter and casted behind the shelter trying to pick up the track. I posted up on the middle of the sidewalk and let Tazer search around for the track to which she kept going back to the bus shelter. I then ended the track at the shelter. I advised dispatch to alert all buses leaving the area of Observatory and Ann streets reference the suspect description.


SUMMARY CONTINUED:

Attempt Armed Robbery

SUMMARY:

This incident was reported on June 24th when the victim was making money drops at the University of Michigan Hospital cafeteria. With 5 money bags in hand (*note: each bag contained \$300 to \$500 of start up money for the cash registers*) the victim was attacked.

INVESTIGATION:

On June 25th I was assigned this case for follow-up. My first stop was to hospital security to view the video evidence that was recovered from the incident. The first file I viewed was the West hallway of the cafeteria. This camera was newly installed within the past 2 months. This new camera showed the suspect entering the west hallway area at 6:09:35. The suspect is seen walking around the area for a few minutes. The suspect then enters the kitchen area at 6:11:12 through the only unlocked door in the hallway. The kitchen area is not open to the public and is not a common thoroughfare. In addition, there are three doors located on the kitchen side of the hallway. The suspect went directly to the only unlocked door in the hallway, showing me that the suspect had prior knowledge of the location.

The suspect is inside the kitchen area until he comes out the first door north of where he entered at 6:43:23. The video camera captured the suspect removing the dreadlock wig and places it inside a sideways pocket of a black/grey messenger bag, not through the top of the bag. As previously reported the suspect is described as a black male, 5'9, thin build, short black hair. The suspect leaves the hospital on the first floor and runs toward Mott Hosp. and enters level two. Employees consistently use this path to and from the parking structure to the main hospital. This area is confusing for the general public because when you leave Mott Hosp. you are on level two and when you enter the main hospital, you are on level 1.

After observing the video, Officer Mundt and I went to the scene of the crime so I could have a firsthand look. Upon arrival, we made contact with Philemon Padonou. Philemon showed me the exact route he chased the suspect at the time of the attempted robbery.

ADDITIONAL INTERVIEW Philemon Padonou:

As Philemon showed me the route he chased the suspect during the above incident. Philemon noted that the suspect knew exactly where he was going when he fled the scene. Philemon stated that the suspect did not hesitate when he was making his turns and going through unlocked door. Furthermore, Philemon reported that the suspect could have exited through the courtyard for a quick getaway, but fled into Mott Hosp. That is the same way employees normally travel. (*note: if the suspect would have fled west through the courtyard he would have ran right by hospital security's offices, showing prior knowledge*)

SUSPECT IDENTIFICATION:

Manager Lynn Noder-Love positively identified the suspect fleeing the kitchen area as Michael Dwayne Thomas. Mike was a previous employee at Einstein Bagles that was terminated back in Dec. 2011 for an altercation. Mike fought his termination with the unemployment office and lost his case due to the victim Mr. Galbraith testifying against Mike. This incident occurred approx. 30 feet from where Einstein Bagels front counter is located. Furthermore, the victim reportedly did the money drops at approximately the same time and manner every day. The incident occurred in a location not open to the public and only a current or former employee would have the knowledge of the money drops and location.

COUNTY WIDE BOL:

A county wide BOL was issued for the arrest of Michael Dwayne Thomas for the attempted R/A.

SUSPECT LOCATED:

Officers from AAPD SIU, WCSD, and UofM PD were actively searching for Mike and his vehicle. On June 27th at approx. 2:30pm I received an anonymous call stating that the suspect was at Russell Anderson Apartments. I immediately notified Lt. Forsberg that I was heading toward the suspect location. While enroute, I notified the WCSD and requested two uniformed deputies to immediately go to Anderson Apartments and attempt to pick up the suspect for the attempted R/A with the stun gun.

Upon my arrival, WCSD Deputy Heddle and Coggins had the suspect in custody in the back seat of a patrol vehicle handcuffed. I notified UofM dispatch that the suspect was secured. I introduced myself to the suspect and informed him that he was under arrest and I would be speaking with him shortly.

The suspect was then transported to UofM PD by Officer Featherstone as units on scene began to search the car and apartment.

VEHICLE / APARTMENT SEARCH:

I asked the suspect if he would give me permission to search his vehicle and apartment at which time he stated "yes, go ahead." When searching the suspect vehicle I located a messenger bag in the trunk that resembled the bag used in the attempted robbery. The recovered bag is black and grey in color and has a black shoulder strap with padding. A search of the bag revealed text books and school material. Furthermore, I noted that the messenger bag had side pockets which are unusual but consistent with the bag in the surveillance footage of the incident. The messenger bag was seized and logged into evidence at 1329 Kipke Dr., UofM PD.

A search of the apartment did not reveal any evidence. The apartment was secured upon completion of the search.

SUSPECT STATEMENT:

The suspect statement was conducted in Interview Room 1 at 1239 Kipke. A request for the video will be made and once available I will release 2 copies to the prosecutors office. The suspect was read his Miranda Warning at which time he waived his rights knowingly and voluntarily and agreed to talk with me. Initially, Mike had the following statement....

- Had no idea why he was arrested
- Didn't know anything about an attempted armed robbery at the hospital
- The hospital doesn't even had money, except for the cafeteria
- Had no idea why someone would implicate him in an armed robbery
- Mike didn't know why someone "ID" him as the suspect
- Mike continued denying ever being at the UofM Hospital on Friday
- Mike stated that he had police contact on Friday at Tuscan Creek in Ypsilanti around 6pm, Mike didn't have any paperwork from that police contact
- *I left the interview and confirmed that Mike had police contact but it was on June 23*
- Mike changed his statement to the police contact to Thursday
- Mike reported that he was with a friend named Victor all day Friday. They got a part fixed on his car by an unknown friend of Victor
 - o Then went to Victors' grandma's house
 - o Didn't know what time they went to grandma's house
 - o Then changed it back to Thursday was the day they went to grandma's house
- When confronted with things not matching up and Mike's story changed and he stated "why don't you look at the cameras"
- The last time Mike was at the UofM hospital was Sunday when he dropped off Victor
- When asked where he dropped Victor off, Mike paused for approx. 8-10 seconds and replied "I don't know" even though he worked at the hospital for over a year
- When I inferred the drop off was in front of "Mott", Mike paused again and stated "it could have been Mott." That was the location where the suspect ran after the attack.
- Mike stated that the kitchen area isn't open to the public and that there are three doors in the west hall leading to the kitchen
- I informed Mike that there are new cameras in the hospital and that he was seen on a camera in the west hall by the kitchen
- When shown a still photo from that camera of the suspect leaving the kitchen area Mike stated "I have no idea" regarding the subject
- Mike had no answer to me asking why people would say it was him
- Mike changed his story to being at Victors the entire day on Friday and Victor's sister Ivy coming over that night
 - o Mike didn't have an approx. time but it was in the evening, Mike didn't have a phone number for Ivy
- Mike informed me to check his phone to confirm his statement
- Mike didn't know when he arrived at Victors on Friday

- when I confronted Mike with the text message from Victor to Mike at 10:12pm on 6/24/11 that stated "everything OK", Mike replied "Yea be there in a few" Mike changed his story to something again
- Mike then stated he was at "Joe Joe's" who has an "810" area code having sex before going to Victors. Mike recalls calling Joe Joe and told Joe Joe that he was out front and for me to check his calls on his phone to prove it
- I checked the call history on Mike's phone and there were no calls to or from an "810" area code on the date of the incident

SUSPECT DISPOSITION:

Officer Featherstone processed and transported the suspect to the WCJ without incident. The suspect will be held pending arraignment. While Featherstone was conducting the processing of suspect, I went to the hospital to locate and interview Victor to confirm the alibi.

OTHER STATEMENT Victor Roberson:

I made contact with Victor as he was working at the hospital on June 27th. As I introduced myself to Victor, I informed him that I wanted to speak to him regarding Mike. Victor confirmed Mike Thomas was the person of conversation and Victor agreed to speak to me in private.

Victor reported that he and Mike hang out everyday together. Victor remembers what he and Mike did together on Thursday and Saturday, but Friday is a blur. Victor stated "I don't know why Friday is such a blank" when asked on details of their activities.

Victor initially stated that he and Mike were together the entire day because Mike spent the night Friday into Saturday. When I informed Victor that Mike told me he had left earlier in the day, Victor stated that Mike may have left around 6 or 7PM but only for an hour or so. Victor recanted that statement and reported the Mike left earlier than that but didn't remember what time. Victor then stated that Mike would leave and go to a friends place and back but wasn't gone for long. Victor couldn't remember specifically when or where Mike would go too when he left.

Victor has known Mike for approx. 3 years. Victor met Mike online and they had an intimate relationship for 2 years until breaking up. They are still good friends. Victor reported that he does not have a vehicle and that Mike drops him off at the Mott Hosp. Employee entrance for work. Victor was not working the night of the reported incident.

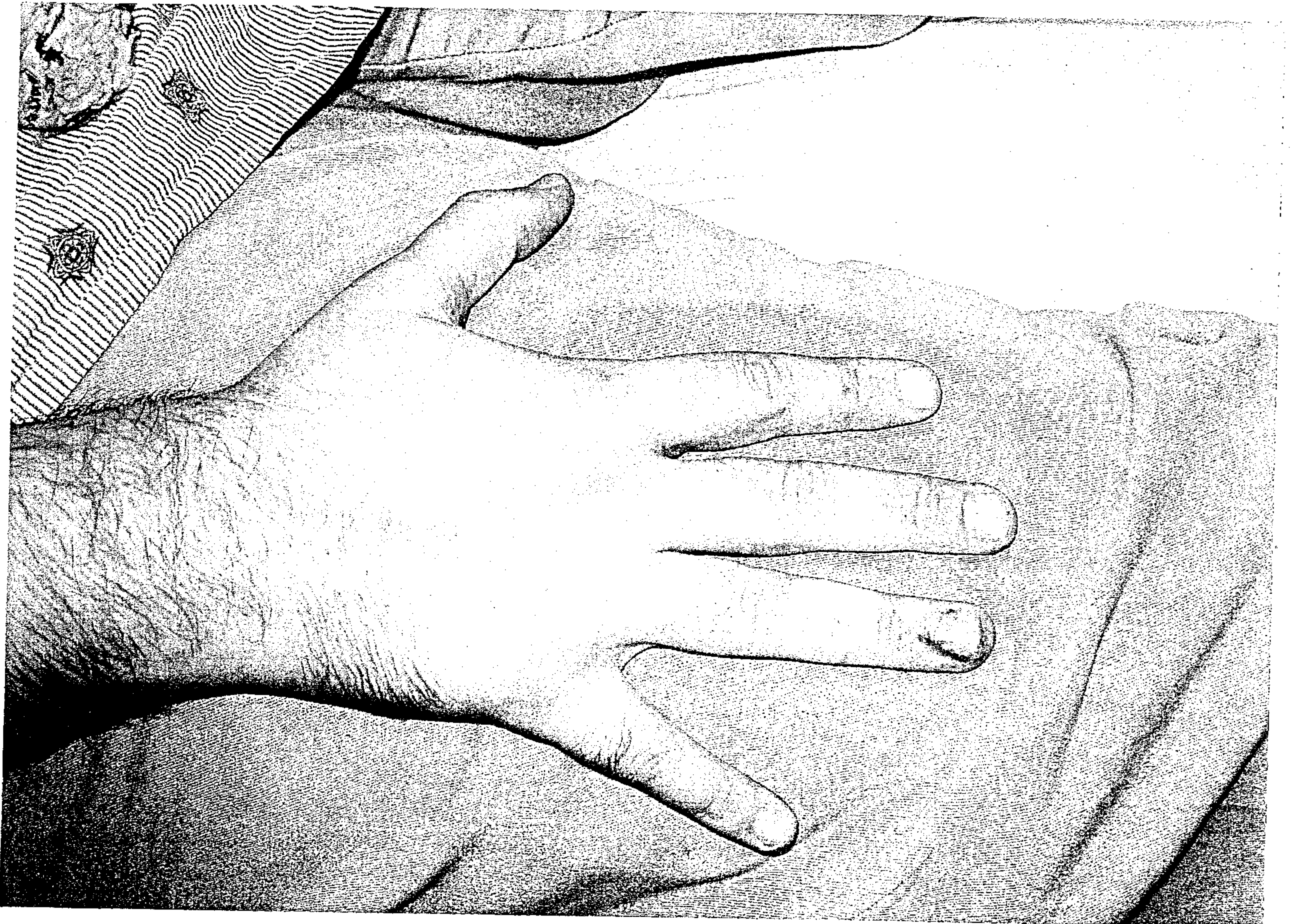

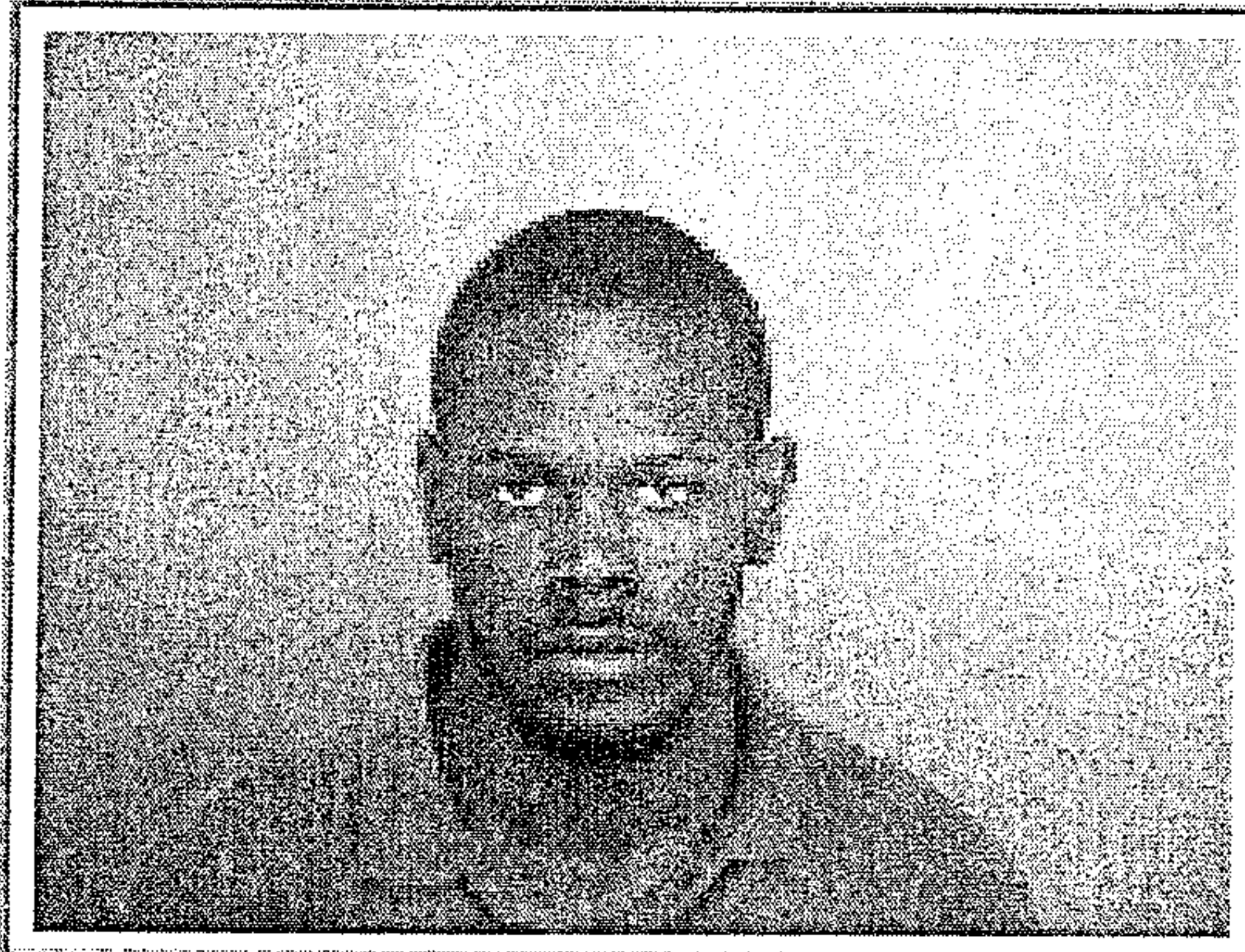
