REPORT:

While on patrol in a fully marked police car, we were dispatched to 1214 S. University for an assault that took place.

Information:

Dispatch advised that the assault was not in progress. Dispatch said there was a white male with dark hair, gray hat and a sweatshirt last seen heading toward the Brown Jug. Dispatch said the victim was only hit with fists and the caller believed the victim might have broken ribs. Dispatch advised that HVA would be en route. Dispatch advised that a second victim, JAMES HUGHES was assaulted by a white male in his mid twenties wearing a red tank top punched HUGHES and went into the Brown Jug. Dispatch described HUGHES as a white male wearing a red plaid shirt.

INITIAL SCENE:

When we arrived on scene there were multiple male subjects standing on the street and on the sidewalk in front of the Starbucks at 1214 S. University. OFFICER RIED and I separated the parties to talk with

everyone individually. All subjects that were on scene were intoxicated. I spoke with the victim, RYAN M. MUNSCH.

VICTIM STATEMENT:

MUNSCH said that he was walking east on the sidewalk of S. University and was just passing the Brown Jug when he was assaulted. He said that he was punched in the face but did not see by whom. He said that when he fell to the ground he was kicked in the ribs. MUNSCH also did not see who kicked him in the ribs, but he thought it was the tall make in the red shirt. MUNSCH said the punch to the face did not hurt but his ribs were causing him pain.

Witness Statements:

The first witness I spoke with was KYLE MUNSCH. KYLE is the brother of the victim RYAN MUNSCH. KYLE said that he and his friends were walking down the sidewalk. KYLE said that he did not see his brother get hit, but saw him on the ground afterwards.

KYLE said his other friend "BMW" fell and hit the outdoor fence in front of the Brown Jug. KYLE said that a random male wearing a gray sweatshirt, glasses with long hair came by kicked "BMW" when he was down.

KYLE said that he did not see who punched or kicked his brother. I could not locate "BMW" at the scene, and KYLE was unable to locate him as well.

Victim HUGHES Statement:

I then spoke with second victim JAMES HUGHES. HUGHES was with KYLE and RYAN MUNSCH when they were walking on the sidewalk. HUGHES said that RYAN MUNSCH was walking on the sidewalk with a megaphone but said he wasn't using it. HUGHES said they were in front of the Brown Jug when RYAN MUNSCH was hit. HUGHES did not see who hit RYAN MUNSCH. HUGHES said he was hit in the face as well, and believed it was the male in the red shirt. HUGHES said he did not see for sure who hit him, but thought the tall white male wearing a red shirt was one of the suspects involved because he was right there when he and MUNSCH were punched in the face with a closed fist. The person HUGHES was describing was TAYLOR LEWAN.

VICTIM INJURIES:

RYAN MUNSCH said he was punched in the face with a closed fist and kicked in the ribs. HVA advised MUNSCH could have an injury to his ribs. HVA advised MUNSCH they recommended he go to University Hospital to get checked out.

HUGHES said that his face was not injured and did not seek medical attention.

FORCE / WEAPON USED:

There were no weapons used in the assault. The victim said he was punched and kicked.

Scene Search:

OFFICER RIED and I searched the area and did not locate anything of evidentiary value.

Investigation:

OFFICER RIED and I asked people that were in the area if they witnessed the assault. We were unable to

find any other witnesses.

Suspect Motive:

The motive behind the assault I believe to be related to the University of Michigan and Ohio State rivalry and to levels of intoxication.

Suspect Info:

There were two descriptions given about the suspect involved. The one description given was by KYLE MUNSCH. He said he saw a male in a gray hat, with dark hair and was wearing a sweatshirt.

The other suspect description was given by HUGHES. He said that a tall male wearing a red t-shirt was the suspect.

Initial Suspect Contact:

I made contact with the tall male wearing a red t-shirt that was at the scene. I asked his name. He said his name was TAYLOR LEWAN.

Suspect Injuries:

The suspect had no injuries.

Suspect Statement:

I asked LEWAN to tell me what happened. LEWAN said that he just got out his taxi and was walking near the Brown Jug with his little brother. LEWAN said that his little brother was hit in the crowd of people walking by. He said he tried to get his brother out of there. LEWAN said he never punched or kicked anyone.

PROSECUTION DESIRED:

RYAN MENSCH said he was not sure if he wanted to prosecute.

HUGHES said that he did not want to prosecute.

I informed Munsch that I had reviewed the initial report, and the report stated victims could not identify the suspect for certain, and the one person who was questioned by police had denied involvement.

Munsch stated he told the police officer that he could not say who kicked him, but he identified the person
