

FOLLOW UP CONTACT WITH DAVID ROOT:

After reviewing the video additional times, I observed another very large white male subject become involved in the confrontation as it progressed. The subject is seen standing in front of the Brown Jug restaurant. I made contact with Root regarding possible identification.

Root informed me that he would speak to staff to attempt to determine his identification. Based on his size, and the circumstances, I believe he may also be a football player.

Root also stated he will view the video to determine if any regular customers known to him in the video may have been witnesses as to what had occurred.

FOLLOW UP AT PANCHEROS RESTAURANT:

I made telephone contact with Victor Nicio regarding his restaurant video, which again, appeared unlikely to have captured activities through the front window. He informed me that he would have the system checked.

Nicio also previously provided the name of Rudolf as a possible witness. On 12/20/13, he informed me that another possible person with whom to speak is Guillermo.

I made contact with Guillermo's sister at [REDACTED] I asked several questions through his sister, who interpreted for me. Guillermo stated there were several subjects involved in a confrontation outside, but he did not see who was involved. He could not identify subjects involved or anyone having been assaulted.

I was informed that additional employees would arrive later this date who may have been working that night.

CONTACT WITH RODOLFO GONZOLEZ:

I spoke with a Rodolfo Gonzalez at approximately 17:30 pm. Gonzalez stated another employee, Bulbo, drew his attention to the confrontation occurring outside. He stated he said, "Hey they're fighting."

Gonzalez stated he was initially concerned about their window getting broken.

Gonzalez stated all he could recall is that all the subjects were white, and they were multiple people punching, shoving and kicking. He stated he could not provide any specific descriptions to who was being assaulted, or who was assaulting or doing the assaulting.

He stated the perhaps Bulbo would know more information, and requested that I contact the restaurant after 10:00 pm this date.

This is a non-priority follow-up. Case #13-58729. Time of 1130 hours. Date: 12/23/13. Reporting: Officer Monroe, Badge 500. Incident Type: Assault.

INTERVIEW WITH BULBO:

At approximately 10:10 pm on 12/20/13, I made telephone contact with Rodolfo Gonzalez, who placed me into phone contact with Bulbo. Gonzalez interpreted for me. I asked Gonzalez to ask what Bulbo saw regarding the confrontation. I asked what he saw happening.



He explained Bulbo said that people were coming from the Brown Jug, and it looked like a bunch of people were crowded, stumbling, and falling down.

I asked if he could describe who was involved, and he described them as "big, tall, muscular white dudes."

He stated he also saw a guy on the ground. I asked if he can describe any of the subjects, and he stated Bulbo remembers a guy in a pink shirt. Gonzalez then stated he (Gonzalez) remembered a guy in a yellow shirt.

I asked if he (Bulbo) could remember what the guy in the pink shirt was doing. He stated he was trying to get at somebody, but he was getting held back. I asked what else he could describe about the subject in the pink shirt, concerning his height or weight. He stated that he was at least 6 foot.

Gonzalez then stated Bulbo said he believe it may involve a guy holding a speaker, the type of speaker the police have. He stated he might have been the person that got hit. He stated Bulbo believes he is an Ohio State fan.

He stated Bulbo remembered him yelling at someone by the Brown Jug earlier, yelling in his face, and then giving him a little shove. I asked Gonzalez to ask Bulbo how long prior to what happened in front of their restaurant, did he see the person with the loud speaker. Bulbo thought maybe 20 minutes.

Gonzalez stated he believes it would be helpful if both he and Bulbo were to meet with me in person. He stated they could meet on the following Tuesday, referring to December 24.

CASE REPORT

Ofc. Monroe

This is a non-priority follow-up to Case #13-58729. Time of 1245 hours. Date of 12/24/13. Reporting: Officer Monroe, Badge 500. Incident type: Assault.

IDENTIFICATION OF SUBJECT IN YELLOW:

On 12/23/13, David Root, from the Brown Jug, informed me the subject in the yellow tank top is believed to be Eric Gunderson. He spoke with other subjects in the restaurant, and based on the team roster, they believe Gunderson to be that individual.

FOLLOW-UP INVESTIGATION:

Three employees from Pancheros Restaurant met with me in the Detective Bureau at approximately 10:30 am on 12/24/13. I had previously spoken with Rodolfo. Accompanying Rodolfo were employee Guillermo Nicio, nickname Bulbo, and employee Gregorio Aguilar-Mirelis.

I spoke with each of the two additional witnesses independently, with Ann Arbor Police Officer Noel Scott interpreting Spanish for me. Through Officer Scott, I asked each what they saw happen on the night of the incident, with Officer Scott explaining each subject's answer to me.

We initiated speaking with Guillermo Nicio at approximately 10:50 am.

GUILLERMO NICIO'S STATEMENT:



Guillermo explained he had been working at the register and had been looking toward the big window at Pancheros. He stated he saw the fight, and is not sure who started it. He stated the people who were involved appeared to be student age, in their 20's, and he saw real big guys. He also saw a guy with a bull horn.

Guillermo explained that a little before, he went to the Brown Jug, had been with Aguilar-Mirelis, and saw the guy with the bull horn kind of messing with people. He described the subject as giving Michigan fans kind of a hard time.

He stated he was trying to get them to give him a "high five." He stated he saw the subject about 20 to 30 minutes before the confrontation occurred. He stated their initial impression, when first observing that subject, was there was going to be trouble with the way the game turned out.

Guillermo described having seen the one big guy with a red color or pink colored shirt with white stripes, describing him as being in the argument or altercation. He stated he saw him gesturing and posturing, but did not actually see him fighting.

I asked about a subject in a yellow shirt.

Guillermo explained to Officer Scott the restaurant was really busy, and what they saw was the aftermath. He stated people were busy, people were running, and had been arguing. He stated he remembered seeing a guy in yellow, but could not say in particular what he had done.

He stated he saw a guy laying there, and he was holding his head.

My interview with Guillermo ended at approximately 11:05 am.

CONTACT WITH AGUILAR-MIRELI:

We then spoke with Gregorio Aguilar-Mirelis. We initiated the interview at approximately 11:07 am.

AGUILAR-MIRELIS' STATEMENT:

When I inquired through Officer Scott what Aguilar-Mirelis had observed that night, he also explained they saw a guy earlier in the day, about 20 minutes before, who had a megaphone. He stated he was asking Michigan fans, "How's it going," and described what he was doing as messing with the Michigan fans. Ofc. Scott stated Aguilar-Mirelis thought there were going to be problems.

He continued by stating he did not see the initial fight, but saw it afterwards. He stated the guy with the megaphone was on the floor, and was holding his face.

He described then seeing a tall white male, clean shaven, with collar-length blonde hair with little curls on the end, wearing a long sleeved shirt with checks on it (red, black, blue) and stripes, who was 20 to 25 years of age, kick the subject while he was on the ground. He described him as kicking the subject on the right side of his face.

He stated he saw a second person then stomp on his face or the side of his head. He described the second person as about 20 years old, a smaller guy, 5 foot 5 to 5 foot 6 in height, and having a thinner build. He described him as having kind of darker short hair, wearing a gray t-shirt.

He stated they stepped away as someone pushed them away for "stomping his buddy." He described the subject with the megaphone as getting up, they moved him down to Starbucks, because people are trying to



go after him again. He stated that about that time, the police and ambulance showed up.

Aguilar-Mirelis described all the subjects involved as white males. He stated he did not see how the subject with the megaphone initially ended up on the ground.

I inquired further about the subject who had first kicked the person on the ground concerning his build. He described him as over 6 foot, possibly 6 foot 1, and having a thin build.

I was complete with Aguilar-Mirelis at approximately 11:20 am.

REVIEW OF VIDEO:

Both subjects inquired as to if they could watch the video. Both stated that possibly they would recognize someone in the video as having been involved.

I reviewed the video with them. As they watched the recording, both immediately identified the subject that I previously identified through David Root as Taylor Luwan, as the person with the pink shirt. Both subjects were following him through the video, and on multiple occasions, indicated he was the person in the pink shirt. In reviewing the recording, no specific assaultive actions could be detected due to the distance and quality of the recording.

As Aguilar-Mirelis continued watching the video, he observed the subject in the yellow tank top, believed possibly to be Eric Gunderson, walking in a westward direction after the incident had occurred, and after leaving the Brown Jug. Aguilar-Mirelis pointed to the subject behind him, stating he was the smaller subject who came up and stomped on the person on the ground.

He stated he was not wearing a baseball hat at the time of the assault, stating that someone else was holding his hat at the time. He stated he was the person that he had described previously to Officer Scott and I.

REVIEW OF SURVEILLANCE RECORDING AT PANCHEROS:

At approximately 12:30 pm on 12/24/13, I met with Victor Nicio at the Pancheros Restaurant to make certain that the interior camera did not depict any detail through the front window on the night of the incident.

We reviewed the current system, which when the actual time was 12:18 pm this date, displayed a time of 12:27 pm. It appeared the clock displayed a time approximately 15 minutes later than the real time.

Based on the incident being recorded at approximately 12:27 pm on the Brown Jug clock, and believing it to be actual time, we checked the Pancheros recording at approximately 12:42 pm.

In reviewing the recording at that time, both Nicia and I could observe several subjects in the restaurant moving quickly toward the front doors.

In reviewing the recording at approximately 0038 hours (again approximately 15 minutes fast), we could observe movement of subjects on the outside of the front window, with little detail showing. We could observe more subjects and more movement as the time went closer to the 12:40 am, and the movement within the restaurant. In reviewing the recording, no specific details as to descriptions or actions could be determined.

Nicia reviewed the overall system, showed that at least 40 days worth of recording were currently
